8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hrs on 2079/08/06 at the **Sakhuwa Prasauni Rural Municipality Office, Sakhuwa Prasauni, Parsa**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the validity period of the bid.
